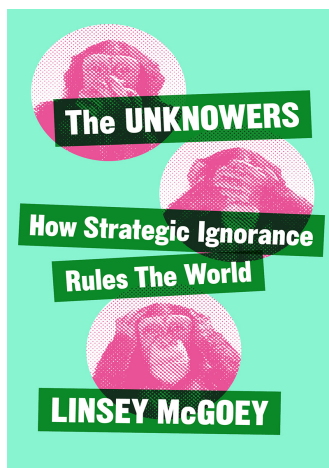

**Field trip to Bolivia August 2019** - He returned to Bolivia to work on a new grant proposal with archaeologist John Janusek (Vanderbilt) in order to develop a joint bid to the ESRC and (US) National Science Foundation. They visited various indigenous communities with various levels of engagement with archaeology and the idea is to conduct research in three of them exploring the role archaeology has in developing indigenous consciousness (especially political consciousness) and, in particular, how understanding the ways their ancestors dealt with climate change in the past influences their attitude and response to climate change today.
