Methodological considerations — explain rationale for selecting primary sources; consider strengths and limitations of primary sources; identify approaches or analytical tools used by scholars for similar sources; specify methods informing analysis or might be needed. Feasibility Report — identify primary sources (and their location), access to sources, travel required, and ethical considerations. Create project plan, outlining objectives for each stage. 
