Sustainable Transitions – Governance, Ecological Management and Society - Leverhulme Doctoral Training Programme 2026-27

The University of Essex is offering seven fully funded interdisciplinary PhD research scholarships in the field of 'Sustainable Transitions'. Applicants can apply for one or more of the following areas of research for which these scholarships are available:

The successful applicants will receive a full PhD scholarship for a maximum of four years, including full tuition fee waiver, a stipend payment towards your living costs, and a research allowance.

Full funding scholarship available is as outlined below.

The stipend rate for 2025-26 is £20,780. The stipend for 2026-27 is to be confirmed.■ A research allowance of £10,000 (in total) to be spent on authorised research costs for example supplies and equipment, field work etc.

Terms and conditions

Eligibility

- Receipt of the scholarship is subject to the applicant also being accepted for the PhD course specified for the project you are applying for. You will need to register as a Full-Time student at the University of Essex for the 2026-27 academic year on a PhD commencing in October 2026, and meet any conditions of our offer. NB It is not necessary to have been accepted for the PhD course that you are applying for at the time of submission of your application for this scholarship, but you must have made a course application.
- These scholarships are restricted to full-time students who are entirely self-funded*.
- Scholarships are for on campus study only (NOT for online or distance learning).

- Applicants must have achieved a Merit or higher Masters level qualification (or equivalence as assessed by our Postgraduate Admissions Team).
- If English is not your first language, you will also need to meet the English language entry requirements for the PhD you have applied for.
- This scholarship is available for a standard 3-year PhD with the possibility of extending up to four years of study.
- The scholarship would not apply to repeat periods of study.
- The award cannot be held in conjunction with any other University of Essex scholarships.
- Successful applicants should be available for promotional activities.
- Awardees will be informed on their Award Letter whether their scholarship is funded by Leverhulme Trust or the University of Essex. Students who are funded by Leverhulme will be known as **‘Leverhulme Trust Doctoral Scholars’** for the duration of their studies. Students who are funded by the University of Essex will not be known as Leverhulme Trust Doctoral Scholars.

*Students receiving a repayable loan to fund their studies will be considered as self-funded.

Students who are not eligible

The following students are NOT eligible for this scholarship regardless of meeting the above criteria:

- This scholarship award does not apply to deferred entry. Where a scholarship has been awarded to a student who subsequently defers entry to the following academic year, the award will be withdrawn and the applicant will be considered again in line with the terms and conditions that apply in the new proposed year of entry.
- Students who are distance learning.
- Students who are fully or partly sponsored.
- Students on a 4-year integrated PhD course

- Current students whose first year of PhD study at the University of Essex, was prior to academic year 2026-27

How to apply

You should apply separately for your PhD course and the scholarship.

On the application form on the 'Course' page, there is a section entitled, '*Proposed research topic or area of research **' - In the adjacent box please note that you are applying for a 'Sustainable Transitions' scholarship and provide the title of the project.

On the same Course Page there is a section that states '*If you have contacted a potential supervisor to discuss your application or research proposal, please provide the person's full name.*' - In the adjacent box please state the name of the primary discipline supervisor for the project.

You should apply for a place to study as soon as possible, and at the latest by **11:59pm BST on Monday 13th April 2026**.

Schedule for Shortlisting and Interviews

- Applicants shortlisted for interview will be informed by 29th April 2026.
- Two rounds of interviews will take place between 7th May to 19th May 2026 and 27th May to 9th June 2026.
- Outcomes for interviewed applicants (i.e. offer, place on waiting list, unsuccessful application) will be made by 26th June 2026.

Payment arrangements

- The tuition fee element of this scholarship will be made available as a waiver of the tuition fee that is payable on registration at the University.
- If you intermit from your course, you may, at the discretion of the University, be entitled to a pro rata payment of the remainder of your award on your return to study. Please contact the [Funding Team](#) for further information.
- This scholarship is awarded for each year of study for a period of up to a maximum of four years. The fee element will be deducted automatically, and the stipend will be paid in quarterly instalments in October, January, April and July. *The university reserves the right to change the payment schedule, for example to monthly, to align with university processes if required.*
- Awards are granted for one year in the first instance but will be renewed, subject to the award holder's satisfactory progress (as defined by the Code of Practice: Postgraduate Research Degrees), for a second, third and fourth year – up to a maximum tenure of twelve terms or four years, provided the award holder is still engaged in full-time research (and excepting the circumstances stated in the section on termination).
- Where progress is satisfactory, renewal of the award is automatic. Students who are exceptionally permitted to extend their period of study beyond the twelve terms will have to meet the additional costs themselves.

Scholarship suspension

Students must be registered and meet the above conditions to receive payment. The scholarship will be suspended during a period of approved leave of absence (intermission) where this period covers a whole or part of an academic year and may be reinstated on your return to full-time study subject to the conditions above. On your return to study, you will be entitled to the balance of the scholarship for the stage. There will be no payment for repeat periods of study in any circumstances.

Holiday

Scholarship holders are entitled to a maximum of eight weeks' holiday (including bank holidays and the University closure at Christmas) per annum and pro-rata. Holidays should be agreed in advance with the supervisor and, in cases where the awardee is engaged in teaching and demonstrating, with the approval of the head of the student's department, school or centre.

Termination of Scholarship

The University will terminate a scholarship when progress or performance is deemed to be unsatisfactory. The scholarship will be terminated if a student ceases to be registered as a student with the University, or for good cause at the discretion of our Dean of Postgraduate Research & Education, or their nominee for this purpose.

If a scholarship is terminated prematurely for any reason, an awardee must repay to the University any monies including maintenance, travel, subsistence, fees overpaid from the date of the termination of the scholarship. If an awardee submits their thesis before the end of the scholarship, the scholarship will be terminated on the date of submission. If an awardee takes up full-time employment whilst in receipt of a scholarship, the scholarship will be terminated as of the first day of employment.

Transferability

Scholarships under this programme relate to specific PhD projects and are not transferable except under exceptional circumstances at the discretion of the Dean of Postgraduate Research Education in consultation with the Director of the Sustainable Transitions – Leverhulme Doctoral Programme.

Data Privacy Statement

The University of Essex takes confidentiality very seriously, your application form will only be seen by members of staff involved in processing your application. Information is kept in accordance with the General Data Protection Regulation (GDPR) as it applies in the UK, tailored by the Data Protection Act 2018. Personal data will be used solely for statistical purposes and electronic record keeping and may be made available to authorised University staff to allow statistical information to be analysed.

Resolution of disputes
