MANDATORY COURSES/INDUCTION and ONLINE TRAINING

All employees are required to complete the following mandatory Health & Safety courses:

HEALTH AND SAFETY ESSENTIALS (online)

Course Outline: is an introduction to your health and safety at the University of Essex. This course is designed for all University of Essex employees including University Committee members, Members of Council and University Steering Group.

COMPUTER SAFETY ESSENTIALS (online)

Course Outline: If you use a computers or other display screen equipment (DSE) (e.g. laptops, microfiche, IPad) as part of your work, it is important that your workstation is set up properly and that you know how to avoid aches and pains.

FIRE SAFETY ESSENTIALS (online)

Course Outline: This course will teach you how to minimise the potential for a fire and to identify potential fire risks. It will also explain how the University controls fire safety risks and how to evacuate buildings safely. The information found on this course can also be applied at home. This course is mandatory for all University staff and new starters who have recently attended the University's new staff induction programme.

MANAGING HEALTH & SAFETY ESSENTIALS (online)

Mandatory course for managers*

Course outline: This briefing covers your responsibilities for managing health and safety and gives an overview of what the University has in place to help you. The course focuses on the health and safety management system. You will complete the Manager health and safety checklist and identify three areas where you want to improve your health and safety management.
