Actioning an Annual Leave request

- When a request for annual leave is submitted by a reportee through HR Organiser, you will receive an email notification stating that there is an action to be done.
- There will be a link in the email to People Manager, or you can <u>log into People Manager</u> on the website you will need to select your employer (University of Essex / UECS / WHH) when prompted and then you will be logged straight in. If you have multiple iTrent roles then choose 'People Manager' from the dropdown list.
- Within People Manager, there is a box entitled 'My to do list / Processes'; this is where the task will be sat awaiting action.



• Click on 'My to do list' and any current/outstanding tasks will be shown.

Option 1

• Tick the checkbox (under the face icon) of the task you wish to action.



 Click on the word 'Actions' that appears above the task list. Select the appropriate option – either 'Authorised' or 'Not authorised' – and the record will be updated accordingly.



Option 2

• Click on the task to view the Task details.



• People Manager will then take you through to the main Annual Leave screen.
