	B: Choose research topic and demonstrate significance/impact of research.	<ul> <li>Complete Ec990 (research project plan) in line with issued guidelines. Obtain a mark of at least 60 in Ec990 by providing clear evidence of the ability to produce <u>original research</u> at the PhD level. This evidence may be either a <u>self-contained</u> <u>complete research paper building toward a full substantive PhD chapter or a substantive research proposal for multiple PhD chapters</u> by the student which meets at least the following minimum requirements.</li> </ul>	By Confirmation Board (Term 3 for full-time students. 		i. The paper or proposal clearly identifies the field of study for the research and outlines the key research question(s) being studied and planned to be studied, including a description of the future research that would develop the submitted research paper or proposal into <u>the draft of at least one substantive PhD chapter</u> <u>by the end of Term 4</u> . (This is the Autumn Term of the following academic year for	



full time students. Please contact the Department for part-time students deadline.)
ii. It includes a brief critical review of the most important relevant literature. It must include a bibliography, containing full and accurate references to the literature cited in the paper.
<ol> <li>It provides evidence of the student's ability to produce <u>original research</u>. This can be empirical work, theoretical work, or a combination of the two and must meet the following conditions.</li> </ol>
a. It must clearly specify the research question and methodology for investigation.
<ul> <li>b. It must contain the <u>results of original preliminary research analysis by the student</u> and must clearly demonstrate that the specified research question and methodology are worthy of investigation for PhD research.</li> </ul>
c. For <u>theoretical research</u> , a well-developed model and results must be provided, which may take the form of extending or modifying existing models.
d. For <u>empirical research</u> , a well-developed methodology and empirical analysis must be provided. This may take the form of utilizing existing data if the data needed for research question are still in the process of being obtained. The sources of and the process by which this new data will be obtained must be clearly specified.
e. The previous condition also applies when empirical work takes the form of <u>calibration exercises</u> common in macroeconomic research
f. Research that combines theoretical and empirical work must meet the criteria outlined above for at least one of the two.
